Feedback Analysis Report (2022-23)

The feedback system of an educational institute regarding its curriculum is a vital component in ensuring the continuous improvement and relevance of the educational programs offered. Sri Guru Teg Bahadur Khalsa College has designed a well-structured feedback system that allows students, faculty, parents, alumni and other stakeholders to provide valuable insights, suggestions and criticisms about the curriculum's effectiveness, content and delivery methods. This feedback system is effective for ensuring continuous improvement and alignment with the needs of students, educators and the broader community. The feedback is obtained from all the stakeholders including Students, Teachers, Alumni and Parents. The feedback was collected through Google Forms for the academic session 2022-23. This feedback was analyzed to check the effectiveness of Teaching-Learning Process in the institute. The following charts represent the analysis of responses/feedback collected from different stakeholders:

1. Feedback from Students: Taking feedback from students about their curriculum is essential for creating a student-centered learning environment. It allows educators to tailor the curriculum to better meet the needs and preferences of the students. Soliciting feedback from students demonstrates that their opinions and experiences are valued, which can increase their engagement and motivation in the learning process. When students feel heard and respected, they are more likely to be actively involved in their education. Feedback sessions provide opportunities for open communication and collaboration between students and educators. Through dialogue about the curriculum, students and educators can exchange ideas, share perspectives and work together to create a more positive and productive learning environment. Sri Guru Teg Bahadur Khalsa College collects feedback from under-graduate and post graduate students through Google Forms. For Session 2022-23, Feedback was collected through a Google Form consisting of 4 parameters. All these parameters are focused on relevance of curriculum, learning values and course outcomes achieved.




Parameter-1: Course Content

Interpretation: Course content forms the foundation of what students will learn throughout the course. It includes essential knowledge, concepts, theories and skills that

students are expected to master by the end of the course. The course content should be relevant and practical, addressing key concepts and skills that are applicable to students' academic and professional goals. For the above mentioned parameter, it was observed that 43% of the students found that the course content was "Excellent" and 42% of the students said that it was "Very Good".



Parameter-2: Extent of course objective achieved









Interpretation: Course objectives serve as benchmarks for measuring students' learning outcomes. Achieving these objectives demonstrates that students have acquired the knowledge, skills and competencies outlined in the curriculum and they are progressing toward meeting these overarching goals and standards. For the above mentioned parameter, 38% of the total students totally believe that the course objectives were achieved. Also, 36% students agreed with the fulfillment of course objectives.

Parameter-3: Learning Value (in terms of knowledge, concepts, manual & analytical Skills and broadening perspective)



Interpretation: Feedback was collected about "Learning Values" gained through curriculum. In response to that 41% of the total students said that curriculum was "Excellent" in providing knowledge, manual & analytical skills and broadening perspective. Also, 35% students agreed that the syllabus was helpful in learning different values.





Parameter-4: Clarity and relevance of syllabus



Interpretation: For the above mentioned parameter, 43% students mentioned that the syllabus was "Excellent" in terms of clarity and relevance and 36% students also agreed that the syllabus was "Very Good" for the same parameters.







Parameter-3: The teachers are allowed to go for training/FDP/ Refresher Course/Workshop



Interpretation: Faculty Development Programmes, Refresher Courses, Workshops, Short Term Courses etc. play a very important role in enhancing the skills, knowledge and effectiveness of faculty members. These trainings provide opportunities for faculty to enhance their teaching and research skills by learning about innovative teaching methods. Also, they come to know how to incorporate technology into the classroom, improving communication skills and staying updated on the latest trends and developments in their field. 57% of the total teachers were "Strongly Agree" with the point that they are allowed to go for training/ FDP/ Refresher Course/ Workshop etc. Also, 37% of the teachers were "Agree" with the same.

Parameter-4: Enough care is taken while framing the syllabus to prepare all necessary academic documentation like POs, COs and PSOs

Interpretation: POs (Program Outcomes), COs (Course Outcomes) and PSOs (Program Specific Outcomes) are essential components of curriculum design and assessment in educational institutes. POs, COs and PSOs help ensure that the curriculum is aligned with

the educational goals and objectives of the program. POs represent the overarching learning outcomes expected of graduates, COs break down these outcomes into specific learning objectives for individual courses and PSOs focus on outcomes that are specific







Parameter-5: The syllabus content is designed on par with industrial requirements


Interpretation: Due to technological advancements, market dynamics and changing consumer preferences, industries evolve rapidly. Employers often seek candidates who

knowledge transfer







Organizing the syllabus in such manner helps ensure a smooth flow of knowledge transfer, allowing students to grasp new concepts in a structured and systematic way. Feedback was collected about whether the syllabus is designed in a way that it has a continuous flow for effective knowledge transfer. In response to that, 52% of the teachers said that they are "Strongly Agree" with this and 42% of the teachers mentioned that they are "Agree" with this parameter.



Parameter-7: Is the change in syllabus is easily adaptable

Interpretation: Changes in the syllabus should ideally be adaptable to various circumstances and contexts. Adaptable syllabi allow for flexibility in teaching and learning approaches, enabling educators to address evolving educational needs, incorporate new research findings, respond to changes in technology and cater to diverse student populations. When faculty was asked whether the change in syllabus is easily adaptable, then in response to that 44% of the teachers said that they are "Strongly Agree" with this and 45% of the teachers said that they are "Agree" with the same.





Parameter-5: The prescribed books were relevant, updated and appropriate


Interpretation: Prescribed books for a syllabus play a crucial role in shaping the learning
